

## What data do we collect?

Lantero collects the following data: Personal identification information (name, email address and phone number)

## How do we collect your data?

Users directly provide Lantero with most of the data we collect. We collect data and process data when a user:

Registers online with a request for a tender Voluntarily completes a customer survey or provide feedback via for example email Use or view our website via your browser's cookies Register information related to our whistleblower services

## How will we use your data?

Lantero collects data so that we can: Provide a tender for our services Manage requirements and track discussions regarding services for clients and potential clients

## How do we store your data?

All data related to our services is stored in secure and encrypted databases on virtual or physical servers at GleSYS, in Falkenberg and Stockholm. Our services will help clients manage reports on misconduct in a timely manner and the data will only be stored as long as case is active. Client data is stored in a Customer Relationship Management System.

## What are your data protection rights?

Lantero would like to make sure you are fully aware of all your data protection rights. Every user is entitled to the following:

- *The right to access* You have the right to request Lantero for copies of your personal data. We may charge you a small fee for this service.
- The right to rectification You have the right to request that Lantero correct any information you believe is inaccurate. You also have the right to request Lantero to complete information you believe is incomplete.
- *The right of erasure* You have the right to request that Lantero erase your personal data, under certain conditions.
- *The right to restrict processing* You have the right to request that Lantero restrict the processing of your personal data, under certain conditions.
- The right to object to processing You have the right to object to Lantero's processing of your

personal data, under certain conditions.

• The right to data portability – You have the right to request that Lantero transfer the data that we have collected to another organization, or directly to you, under certain conditions.

### What are cookies?

Cookies are text files placed on your computer to collect standard Internet log information and visit behavior information. When you visit our websites, we may collect information from you automatically through cookies or similar technology.

#### How do we use cookies?

Lantero uses cookies to improve your experience on our website, mainly by understanding how you use and navigate the website.

## What types of cookies do we use?

There are a number of different types of cookies, however, our website uses cookies:

- To improve the function of the website
- To facilitate the use of the website
- To measure whether visitors can easily find information on our website
- To analyze our incoming website traffic

### How to manage cookies

You can set your browser not to accept cookies. However, in a few cases, some of our website features may not function as a result.

#### Privacy policies of other websites

The Lantero website contains links to other websites. Our privacy policy applies only to our website, so if you click on a link to another website, you should read their privacy policy.
